Chapter 1 Overview

1.1 Independent Hospital Pricing Authority

The Independent Hospital Pricing Authority (*Pricing Authority*) is established under the National Health Reform Act 2011 (Cth) (*Act*), and by virtue of section 131(1) of the Act is invested with the following functions relevant to this National Efficient Price Determination 2014 (*Determination*):

- (a) to determine the national efficient price for health care services provided by public hospitals where the services are funded on an activity basis;
- (b) to determine the national efficient price for health care services provided by public hospitals where the services are block funded;
- (c) to develop and specify classification systems for health care and other services provided by public hospitals;
- (d) to determine adjustments to the national efficient price to reflect legitimate and unavoidable variations in the costs of delivering health care services;
- (e) except where otherwise agreed between the *Commonwealth* and a *state* – to determine the public hospital functions that are to be funded in the state by the Commonwealth; and
- (f) to publish a report setting out the national efficient price (*NEP*) for the coming year and any other information that would support the efficient funding of public hospitals.

This Determination is the initial output of the performance of those functions by the Pricing Authority.

In this document, 'Pricing Authority' refers to the governing members and 'IHPA' refers to the Agency.

1.2 Data quality

In making this Determination, the Pricing Authority has relied on a number of different data sources.

Costing information used to determine the NEP has been drawn from the *National Hospital Cost Data Collection* (NHCDC) Round 16, as provided by states and territories. Significant improvements in the quality of this data have been noted. However, the Pricing Authority recognises the limitations of this data and conducted a separate detailed costing study for both non-admitted and sub-acute services. The results of the non-admitted costing study have been used in the development of NEP14.

IHPA continues to review and refine the classifications systems used in the national pricing model.

Notwithstanding these limitations, the Pricing Authority is satisfied that this Determination is fit for use for pricing public hospital services in 2014-2015.

1.3 Determination development

In performing the functions outlined above and preparing this Determination, the Pricing Authority has had regard, as required pursuant to sections 131(3) and 132 of the Act, to:

- (a) relevant expertise and best practice within Australia and internationally;
- (b) submissions made at any time by the Commonwealth or a state or territory;
- (c) the need to ensure:
 - (i) reasonable access to health care services;
 - (ii) safety and quality in the provision of health care services;
 - (iii) continuity and predictability in the cost of health care services; and
 - (iv) the effectiveness, efficiency and financial sustainability of the public hospital system;
- (d) the range of public hospitals and the variables affecting the actual cost of providing health care services in each of those hospitals; and
- (e) relevant intergovernmental agreements (including the National Health Reform Agreement 2011 (*Agreement*)).

1.4 Terminology

Although the Pricing Authority aims to use plain English to make its documents accessible to a wide audience, the subject matter of this Determination requires the use of some specialist terms. For ease of reference, the meaning of those terms is set out in an [electronic glossary](http://www.ihpa.gov.au/internet/ihpa/publishing.nsf/Content/national-efficient-price-determination-lp) available at <http://www.ihpa.gov.au/internet/ihpa/publishing.nsf/Content/national-efficient-price-determination-lp>.

Defined terms are capitalised where used throughout this Determination; the first use of any defined term is in italicised text.

Chapter 2 National Efficient Price 2014-15

2.1 The NEP

The NEP is \$5,007 per National Weighted Activity Unit 2014-15 (NWAU(14)).

2.2 Calculation of the NEP

The NEP is based on the projected average cost (PAC) of an NWAU(14).

The PAC is derived from the reference cost of public hospital activity in the 2011-2012 financial year of \$4,464, indexed at a rate of 3.9 per cent per annum.

Consistent with clause B12(e) of the Agreement, in calculating the NEP, the following Commonwealth funded programs have been removed prior to determining the underlying cost data of the 2011-12 reference cost:

- Highly Specialised Drugs – Section 100 Funding (\$737.6 million in the 2011-12 financial year);
- Pharmaceutical Reform Agreements – Efficient Funding of Chemotherapy (Section 100 funding) (\$106.0 million in the 2011-12 financial year);
- Trastuzumab (Herceptin ®): HER2 Early Stage Breast Cancer PBS – Herceptin: Early Stage Breast Cancer – Section 100 Funding (\$19.5 million in the 2011-12 financial year); and
- Pharmaceutical Reform Agreements – PBS Access Program (\$115.7 million in the 2011-12 financial year).

Where blood expenditure has been reported in the NHCDC by states and territories this has also been removed, as Commonwealth funding for this program is provided directly to the National Blood Authority. In 2011-12 this amounted to \$152.7 million.

2.3 Price of an ABF activity

The price of an ABF Activity is calculated using the following formula, with Adjustments applied as applicable:

Price of an admitted acute ABF Activity =

$$\{[PW \times A_{Paed} \times (1 + A_{SPA}) \times (1 + A_{Ind} + A_A + A_{RT}) + (A_{ICU} \times ICU \text{ hours})] - [(PW + A_{ICU} \times ICU \text{ hours}) \times A_{PPS} + LOS \times A_{Acc}]\} \times NEP$$

Price of an admitted subacute ABF Activity =

$$\{[PW \times A_{Paed} \times (1 + A_{Ind} + A_A)] - [PW \times A_{PPS} + LOS \times A_{AAC}]\} \times NEP$$

Where:

A_A	means each or any <i>Remoteness Area Adjustment</i>
A_{Acc}	means the <i>Private Patient Accommodation Adjustment</i> applicable to the state of hospitalisation and length of stay
A_{ICU}	means the <i>ICU Adjustment</i>
A_{Ind}	means the <i>Indigenous Adjustment</i>
A_{Paed}	means the <i>Paediatric Adjustment</i>
A_{SPA}	means the <i>Specialist Psychiatric Age Adjustment</i>
A_{PPS}	means the <i>Private Patient Service Adjustment</i>
A_{RT}	means the <i>Radiotherapy Adjustment</i>
ICU hours	means the number of hours spent by a person within a <i>Specified ICU</i>
LOS	means <i>length of stay in hospital (in days)</i>
NEP	National Efficient Price 2014
PW	means the Price Weight for an ABF Activity as set out at Appendix F

In the event that the application of the Private Patient Accommodation Adjustment and the Private Patient Service Adjustment returns a negative NWAU(14) value for a particular patient, the NWAU(14) value is held to be zero - that is, negative NWAU(14) values are not permitted for any patients under the National Pricing Model.

Note: the definition of A_{PPS} as the Private Patient Service Adjustment is now expressed as a discount and equates to (1 - A_{PPS}) in NEP13.

Chapter 3 In-scope public hospital services

3.1 Overall scope

In accordance with section 131(f) of the Act and clauses A9–A17 of the Agreement, the scope of public hospital services eligible for Commonwealth funding under the Agreement is as follows:

- (a) all admitted programs, including hospital in the home programs. Forensic mental health inpatient services are included as recorded in the 2010 Public Hospital Establishments Collection;
- (b) all Emergency Department Services provided by an Emergency Department; and
- (c) non-admitted services as defined below.

3.2 Non-admitted services

The listing of in-scope non-admitted services is independent of the service setting in which they are provided (e.g. at a hospital, in the community, in a person's home). This means that in-scope services can be provided on an outreach basis.

To be included as an in-scope non-admitted service, the service must meet the definition of a *Service Event* which is:

“an interaction between one or more healthcare provider(s) with one non-admitted patient, which must contain therapeutic/clinical content and result in a dated entry in the patient's medical record.”

Consistent with clause A25 of the Agreement, the Pricing Authority will conduct analysis to determine if services are transferred from the community to public hospitals for the dominant purpose of making services eligible for Commonwealth funding.

There are two broad categories of in-scope, public hospital non-admitted services:

- (a) Specialist Outpatient Clinic Services; and
- (b) Other Non-admitted Patient Services.

Category A: Specialist outpatient clinic services – Tier 2 Non-admitted Services Classification – Classes 10 and 20

This comprises all clinics in the Tier 2 Non-Admitted Services classification, classes 10 and 20 with the exception of the General Practice and Primary Care (20.06) clinic and series 30 clinics, which are considered by the Pricing Authority as not to be eligible for Commonwealth funding as a public hospital service.

Category B: Other non-admitted patient services and non-medical specialist outpatient clinics (Tier 2 Non-Admitted Services Class 40)

To be eligible for Commonwealth funding as an Other Non-admitted Patient Service or a Class 40 Tier 2 Non-Admitted Service, a service must be:

- (a) directly related to an inpatient admission or an emergency department attendance; or

- (b) intended to substitute directly for an inpatient admission or emergency department attendance; or
- (c) expected to improve the health or better manage the symptoms of persons with physical or mental health conditions who have a history of frequent hospital attendance or admission.

In the National Efficient Price Determination 2013-14, IHPA released the first list of non-admitted public hospital services under Category B “Other Non-Admitted Patient Services” in scope for Commonwealth funding under the Agreement. Prior to preparing this Determination (2014-15), jurisdictions were invited to submit evidence for additional services to be included or excluded from that list based on the criteria above.

The following clinics are considered by the Pricing Authority as not to be eligible for Commonwealth funding as a public hospital service under this category:

- Commonwealth funded Aged Care Assessment (40.02);
- Family Planning (40.27);
- General Counselling (40.33);
- Primary Health Care (40.08).

Interpretive Guidelines for Use

In line with the criteria for Category B, community mental health, physical chronic disease management and community based allied health programs considered in-scope will have all or most of the following attributes:

- Be closely linked to the clinical services and clinical governance structures of a public hospital (for example integrated area mental health services, step-up/step-down mental health services and crisis assessment teams);
- Target patients with severe disease profiles;
- Demonstrate regular and intensive contact with the target group (an average of 8 or more service events per patient per annum);
- Demonstrate the operation of formal discharge protocols within the program; and
- Demonstrate either regular enrolled patient admission to hospital or regular active interventions which have the primary purpose to prevent hospital admission.

Chapter 4 Price Weights

4.1 Price Weights

Price Weights expressed as NWAU(14), are set out at Appendix F, by classification.

4.2 Classification systems

The classification systems used are:

- (a) AR-DRG version 7.0;
- (b) URG version 1.4;
- (c) UDG version 1.3;
- (d) Tier 2 non-admitted services V3.0; and
- (e) AN-SNAP version 3.0

Chapter 5 Adjustments

5.1 Adjustments

Adjustments to Price Weights (expressed as NWAU(14)) are to be applied in the manner and in the order indicated by the formula for determining the NWAU(14) value (price) of an ABF Activity (refer Chapter 2).

5.2 Precedence of Adjustments

To avoid doubt, Adjustments have the following order of precedence of application:

- (a) Paediatric Adjustment; then
- (b) Specialist Psychiatric Age adjustment; then
- (c) Patient Remoteness Area Adjustment; then
- (d) Indigenous Adjustment; then
- (e) Radiotherapy Adjustment; then
- (f) ICU Adjustment; then
- (g) Private Patient Service Adjustment; then
- (h) Private Patient Accommodation Adjustment.

Circumstances in which Adjustments are to be applied are described in Table 1.

Chapter 8 Back-casting

Clause A40 of the National Health Reform Agreement outlines that where the Pricing Authority makes any significant changes to the ABF classification systems or costing methodologies, the effect of such changes must be back-casted to the year prior to their implementation for the purpose of calculating Commonwealth funding for each ABF service category.

In accordance with Clauses A34(b) and A40 of the NHRA, the Pricing Authority has applied the methodological changes to NEP13 and determined the back cast NEP13 for the purposes of determining Commonwealth growth funding between 2013-14 and 2014-15 is \$4,819.
