1. Overview

The National Efficient Cost Supplementary Determination 2019-20 supplements the National Efficient Cost Determination 2019-20 issued by the Pricing Authority on 27 February 2019.

This Determination includes additional block funded services information regarding the efficient cost of these services following the receipt of updated advice from states and territories after the finalisation of state and territory government budgets.

Funding arrangements for CAR-T therapy

In July 2019, the Commonwealth, New South Wales and Victoria agreed funding arrangements for the provision of CAR-T therapy (Kymriah) to treat acute lymphocytic leukaemia in children and young adults.

The Commonwealth agreed to block fund the cost of the treatment for a period of two years commencing in 2019-20 due to the high cost and potential variation in resource utilisation. The activity and associated National Weighted Activity Units (NWAU) will be excluded from the 6.5% cap in overall growth calculation for 2019-20 and 2020-21.

The actual number of patients treated and associated costs will be reconciled by the Administrator of the National Health Funding Pool at the end of the 2019-20 funding period.

The indicative costs for Kymriah treatment is based on three key costs:

- fixed component for costs associated with maintaining service capability;
- · variable component for costs associated with patient care; and
- accommodation and transport costs associated with accommodating the patient and carer close to the treating hospital for the treatment period.
